Entry Form

Each school district can submit a maximum of 5 drivers in the conventional and transit division (plus one alternate for a total of 6 in each division). Trophies will be distributed to the 1st, 2nd, & 3rd place individual drivers in conventional and transit categories. Team trophies will be awarded based on the top three scores for the individual drivers from each district, regardless of whether the individual competed in regular or transit categories.

To be eligible for competition, drivers must meet the following requirements:

1. The driver must be involved in the transporting of public school children in state specified school buses.
2. Must have a valid Texas CDL-A or B driver's license
3. Must hold a current valid State Certification Certificate (enrollment certificate is not valid).
4. Must have no chargeable school bus accident (as defined by the National Safety Council) since September 1, 2018

In addition the district that the driver represents must be a member in good standing of the Region X or Region XI Transportation Association and must have had representatives attend at least 3 meetings of their association during the 12 months prior to the competition.
